The foundation completed a 30-minute documentary film, "Profiles in Service: It Takes a Nation" as a critical component of our AWARENESS program. This film profiles four service members and family members and vividly portrays the depth of their service and sacrifice as motivation for the audience to commit to their support, and, in turn, commit to serving in some capacity to help strengthen the nation. The film had a VIP premiere in June at the Women in Military Service Memorial at Arlington Cemetary, and a public premiere at the National Archives in November.

The foundation continued to gather signatures on the Code of Support via its web site, with each signature accompanied by a dedication honoring service members past and present. Over 3000 additional signatures were added to the Code during the year.

The foundation continued its Grants and Donations program during the year, focusing on several "Critical Issues" which the foundation has identified as being seriously under-resourced. In particular, the foundation engaged in activities in support of Mental Health (PTSD and TBI) and Veterans Employment. We identified three high-quality, scalable organizations addressing mental health and made significant grants to them to help them expand their efforts in support of the troops, military families and veterans.
