We added both additional staff and volunteers, and served to over 500 service members, veterans, and their family members.

Our team of trained case coordinators and veteran peer navigators are dedicated to helping military and veteran families in crisis. We work to identify, prioritize and fulfill the often multiple and complex needs of these families by partnering with a network of organizations across the country to ensure their successful transition into civilian life. Within the past two years, we have seen tremendous expansion in the demand for our case coordination services and we are rapidly

We expanded our staff capacity to support this program and in 2016 we will be piloting our technology platform "for free" with agencies and nonprofits across the country.
